Transponders:

If you own your own AMB transponder, there is no fee.
Rental fee - \$8.00. Karters in the same family can share the same transponder as long as they race in separate divisions. If the transponder is damaged while in your possession, you will be charged a \$215 replacement fee. Transponders must be returned before leaving the track.

Rules:

Inspections:
